- 1452** Cllr C Duckworth reported on the Youth Liason Forum to the members. Penmaenmawr is now down to street visits. The club is back on track and should be finished by end of December for an opening in January. The forum is trying to engage with a group of cannabis users some in early teens. There are no youth club facilities in Dwygyfylchi and it also appears that a previously disruptive group have moved on. The take up ratio of members show's that boys are easier to enrol than girls. It was carried unanimously.

### **1459 Traffic Issues**

Cllr K Stevens reported that he has been in discussion with Conwy Council officers with regards to various issues. A number of double yellow lines and "No Waiting" signs will be formally presented by Conwy Council and then if no objections, they will be implemented. There will also be a space for a disabled vehicle outside Spar and a "Please Drive Carefully" sign. It was requested that double yellow lines be placed near Ysgol Capelulo and also at Penmaenan.

Regarding the Welsh translation signs on the cycle track, it was decided to write to the council pointing out mistakes in the translation.

"No Dogs" signs in the park to be placed on the next agenda.

### **1461 Distribution of the Newsletter**

Discussed was using either the Youth Justice Service or existing paper boy/girls to distribute the newsletter. As time was limited with an October date on the paper, it was decided for this year to use Door 2 Door for distribution with future options available of YJS and existing paper rounds to be considered for the future. Proposed by Cllr S Banwell and seconded by Cllr C Drury.

### **1463 Town Clerk ideas**

It was decided that a petty cash disbursement of £50 be allowed with the following regulation.

- a) No item over £10 be purchased on petty cash without the prior approval of the Mayor.
- b) No item over £25 be purchased through the petty cash system.
- c) All receipts to be accounted for when issuing re-imbusement.
- d) Replenishing the float to be done as and when required.

It was agreed to purchase a digital camera for Town Council use. A maximum spent of £80 be allowed for the purchase.

Starting in January, the office will stay open from 8.00am one day a month on a trial basis as then cover will be available 8.00am to 6.00pm during a month for people who work full time and wish to visit.

A business plan to be done for the Council for a period of 5 years.

**1464 Completion of redecoration of 3 Central Buildings**

This is required asap. With visiting Mayors and consorts in the building for the Light up pen event on Saturday, a nice clean, painted toilet facility is essential. The tender for £240.00 was accepted by the Councillors as it also included labour in putting up Mayoral Boards and other town council assets.

**1465 Co-option of 2 councillors in Capelulo ward and 1 in Pant yr Afon Ward**

3 applications were received. One applicant was not on the electoral register having only just moved to the area and therefore in accordance with electoral rules, could not be considered. However, it was decided that a letter be sent informing the individual to try again in the future as and when a vacancy arises.

The other 2 councillors had not stated as to which ward they were applying for, and the Town Clerk needs to contact both applicants for this information.
