1511 Code of Conduct/Declaration of Interest

Cllr D Owens declared an interest in item 1527 (Bus for Light up pen event) as he is a volunteer for the event. Councillor D Owens did not vote on this matter.

1512 Signing of Minutes of meeting held on 3rd November 2009

The minutes of 3rd November 2009 were agreed and signed.

1513 Signing of translated minutes of Meeting 3rd November

The translated Minutes of the 3rd of November 2009 were approved by Cllr Nia Pritchard.

1514 Signing of Minutes of exempt item held on 27th October 2009

The minutes of the Exempt Meeting on 27th October were agreed and signed.

1516 Matters Arising

- (i) Members required that the matter of cycling on the Promenade be put back on the agenda for the 15th of December 2009 for further discussion.
- (ii) Councillors also commented that several had been approached by residents of Merton Park who had concerns regarding the proposed yellow lines to be painted in the area. A petition has been presented to Conwy Council together with several letters objecting to the plan to Conwy Council and the Town Council. These will be on the next agenda. A councillor enquired if it is possible to have a temporary period of double yellow lines, another councillor did not think this would be possible. Members commented that the matter is currently at the proposal stage whereby all interested parties including the residents will be allowed to voice their concerns to Conwy Council in a process that could take up to 6 months until completion.

1520 2010/11 Precept

This item together with Minute 1521 below was discussed by Members. Cllr S Banwell led the discussion explaining to members the document and that it was work in progress which must be finalized by early January 2010.

Councillors were reminded to inform the clerk of any additional expenditure not on the discussion paper prior to the next meeting.

1521 2010/11 Budget

See item 1520 above. Both 1520 and 1521 to be placed back on the agenda for the next meeting.

1522 Co-option of 2 Councillors in Capelulo ward and 1 in Pant yr Afon Ward

A new letter has been received for one of the above post and was discussed by the Councillors. For the Capelulo ward, it was proposed by Cllr C Drury and seconded by Cllr. V Mooney that Kelly Williams be co-opted as a Councillor.

The other Councillor co-opted for this ward was Liz Dyke with a request that Ms Dyke would be willing to stay on this ward even if a vacancy comes up in another ward until at least the next election. This was proposed by Cllr N Pritchard and Cllr. S Banwell seconding.

The clerk is to write to Ms Dyke informing her of the wishes of the town councillors that she stays as the Councillor for the Capelulo ward until the next election.

It is noted that Cllr. D Owens and Cllr. C Drury abstained.

For the Pant yr Afon Ward, it was proposed by Cllr F Macdonald and seconded by Cllr V Mooney that Mr Jim Crinigan be co-opted to the Town Council.

1523 Internal Controls – see 1361 & 1467

Item to be deleted from the minutes as it is already covered under Audit Report. Previous minutes to be checked to ensure that all matters are covered.

1524 Community Centre Committee

Cllr H. Jones also confirmed his resignation from the Community Centre Committee. Cllr M Baines recorded that there are no more monies to be given to the Centre. All the grants for the year have been handed over. There is an outstanding payment of £1900 for the windows, which is to be placed on the next agenda. It was decided to bring the Community Centre back on the agenda for January 2010.

- 1525 “No Dogs” signs in the Park**
The following needs attention.
- Dog bin needs removing from the grass adjacent to the chalets on the promenade and needs to be placed on the pole near the safety signs.
 - Clerk to write to Conwy Council to ensure that all public park areas have a sign. An extensive list was provided for the clerk to implement.
 - Clerk to ask Conwy Council what they can do alternatively to tackle dog mess in Penmaenmawr.
 - Councillors suggested that all dog bins have free bags for convenience to dog owners.
- 1526 Fridge and Shredder**
As the shredder is broken, the clerk is authorized to purchase a new one up to the value of £70.00. Fridge is to be purchased to keep milk for the office.
- 1527 Arriva Bus Shuttle**
Proposed by Cllr C Drury and seconded by Cllr D L Borland to provide a sum of £200 to “Light up Pen” for payment to Arriva to re-route the bus on the evening of the Christmas lights switch on. Cllr S Banwell suggested to review the contribution to “Light up Pen” in the future.
- 1528 Penmaenmawr community Environment Group – Vat reclaim on items**
This was agreed with the Town Council retaining ownership of the item and for them to appear on the Asset Register. The clerk was requested to check how much has been paid over to “Pen in Bloom” during the current financial year.
