**Presentation**

- 1804** PCSO Nicola Adams: Referring to the murals on the wall by the beach, it was stated that they are of a cartoon character called “The Incredibles”. It was funded by local businesses and without any grants whatsoever. Lots of praise has been received for them and the total cost was £685. Previous to the murals being painted attracted a number of disgusting graffiti, which has now stopped. It is proposed

- 1805** Celia Williams on behalf of Crest : An organisation which assists with Social Inclusion with re-cycling schemes and promoting re-using of materials and products. Funded by the Lottery and ESF funds the company (Ltd by guarantee) have 4 main schemes.

  - (2) Trash & Cash
  - (3) Against the Grain (Wood Recycling)
  - (4) Recycling Textiles

They distribute food to the needy and poor and have a 3 year contract with Cartrefi Conwy.
