1681 Traffic Matters

It was formally noted that the Town Council is appreciative of the work done by Councillor Ken Stevens in relation to the current improvements being done in the centre of Penmaenmawr at present. Regarding the traffic issues and double yellow lines, a series of plans were displayed and the Town Council decided to consult with residents and the people of Penmaenmawr and Dwygyfylchi by having a full week of displaying the proposals in Conwy Council with the general public being invited in during that time to give their comments in relation to the proposed plans.

The plans will also be displayed in the window of the Town Council and comments collected and reviewed in order to form an opinion.

The week in question will be from Tuesday 2nd of March up until Saturday 6th of March 2010.

An advert/story will appear in the Weekly News/Daily Post.

Use of the council website will also be done to highlight the event.

Clerk to prepare a form for feedback and to liaise with Councillor K Beard.

1682 Board above Front Door

An enquiry was made to Conwy Council regarding the need for planning permission to cover the vent above the front door. A picture has been emailed to the department together with answers to questions raised.

1683 Office Security

Decided to use a "star key" as an added level of security for the front door. Door to the clerks office also to be fitted with an approved lock.

1684 Drop kerb by Nat West Bank

Following concerns regarding the new footway and the raised kerb by the bank, clerk has spoken with Conwy Council who have stated that there will be a path alongside the entrance to the bank to the car park eventually with full access for the disabled.

1685 Community Skips outstanding balance request.

Having received a request for an outstanding invoice of £414.00, it was stated that the only skip received was Fernbrook Road. The others were not provided.

1686 Council Website Expansion

To try an engage with the business sector in the area, it was agreed to have a page on the council's website linked to local businesses.

1687 Underpass to Penmaenmawr Beach

Members felt that the existing mural was rather intimidating in it's design and perhaps now is the time for a new cheerful thematic scheme which would be in line with promoting Penmaenmawr as a nice place to live and visit. Clerk to contact PC Mike Smith for his views.

1688 Criteria for application to Penmaenmawr project Cushion Fund

Clerk had prepared a consultation paper with an opportunity for each member to put their own views forward. Clerk to liaise with Councillor K Beard.

1689 Recording of Town Council Minutes

A trial period to March 2010 was approved with recordings being erased once the minutes have been approved by the Council.

1690 Commemorative Benches

Decided to move ahead and for the Mayor to order two new benches to be placed over the Ironbridge. Clerk to contact Cllr. Gail Hall as arrangements were in hand for her to pursue Conwy Council to clear the area.

1691 Public Work Loan Board (PWLB)

Applications are being invited from Local Authorities, Town and Community Councils for Loans from the Public Work Loan Board (PWLB) for any capital work in the area. The rate of interest is low and the term can be upwards of 50 years so that capital costs are spread over a longer spell of ratepayers who would benefit from the works.
