Youth Justice have cleaned the foreshore and a letter of thanks to be sent to them from the Town Council.

The Harbourmaster has also arranged to remove the remains of the old chairs – also a letter of thanks to be sent.

## Presentation

### Action

- 1928 Town Council Chairs:** Members agreed that the price of £8 per chair from the Community Centre was reasonable. **Action: Clerk to proceed to buy the chairs but firstly to obtain an invoice from the Community Centre.**
- 1929 Community Centre – Utilities Bills:** What is required is the financial accounts of the Community centre for the previous year so that arrangements be in place for the Town Council to cover the cost of utilities. Concern was also raised that lights are being left on when no one is there and the Town Clerk to discuss the matter with Mr John Jones. **Action: Cllr S Banwell to arrange that a copy of the accounts be provided for the town council.**
- 1930 Dog Warden:** 8 sites visited. Worse site was The Esplanade, and the iron Bridge is also very bad. There are only 2 wardens to cover the whole of Conwy. **Action: Clerk will distribute contact details of the warden to members be provided for the council.**
