Fel un o rinweddau arbennig Parc Cenedlaethol Eryri, mae'n ddyletswydd arnom fel Awdurdod i warchod yr iaith Gymraeg. Bydd llawer ohonoch yn ymwybodol bod y Gymraeg wedi bod yn rhan annatod o ethos a diwylliant ein sefydliad ers ein sefydlu fel Awdurdod Parc Cenedlaethol; ac ar wahân i'n hegwyddor gyffredinol o ddarparu gwasanaeth cwbl ddwyieithog i'r cyhoedd ar bob achlysur, rydym hefyd yn gweithio'n galed i hyrwyddo'r iaith ymhlith trigolion lleol ac ymwelwyr fel ei gilydd trwy bob agwedd o'n gwaith beunyddiol.

Fel Awdurdod cyhoeddus mae gennym hefyd ddyletswydd statudol i gydymffurfio â safonau'r Gymraeg a osodwyd arnom gan Gomisiynydd y Gymraeg o dan Fesur y Gymraeg (Cymru) 2011. Un o'r safonau hyn yw'r gofyniad i gael Strategaeth 5 mlynedd i Hybu'r Gymraeg.

Rydym wedi bod yn gweithio ar gynhyrchu drafft cychwynol o'n ail Strategaeth Hybu'r Gymraeg ar gyfer y cyfnod 2022 - 27, ac mae copi wedi'i amgáu.

Byddem yn croesawu'n fawr eich mewnbwn a'ch adborth ar y cynnwys, wrth i ni agor ymgynghoriad cyhoeddus 8 wythnos ar y Strategaeth ddrafft.

**Public Consultation:
Draft Welsh Language Promotion Strategy
for 2022 – 27**

As one of the special qualities of Eryri National Park, it is our duty as an Authority to conserve the Welsh language. Many of you will be aware that the Welsh language has been ingrained into the ethos and culture of our organisation from our inception as a National Park Authority; and apart from our overarching principle to always provide a fully bilingual service to the public, we also work hard to promote the language with both local residents and visitors alike through every aspect of our daily work.

As a public Authority we also have a statutory duty to comply with the Welsh language standards which have been set on us by the Welsh Language Commissioner under The Welsh Language (Wales) Measure 2011. One of these standards is the requirement to have a 5 year Welsh Language Promotion Strategy in place.

We have been working on producing an initial draft of our second Welsh Language Promotion Strategy for the period 2022 – 27, a copy of which is enclosed.

We would very much welcome your input and feedback on its contents, as we open up an 8 week public consultation on the draft Strategy.


